#### **Residential Alarm Registration Form**

Twp. Ordinance # 13 -104 C. False alarms; registration of alarm system
Failure to register with the Police Department an alarm system, to include but not be
limited to burglary, robbery and fire within 24 hours of the installation. Registration is to
include the name, address, municipality/township and telephone number of the subscriber
and the installer and the name and telephone number of at least one person who has

knowledge and means to reset the alarm.

# **Ensure Your Safety By Confirming Your Municipality**

We all value our possessions and want to protect them from potential thieves. Even more vital is the safety and security of our loved ones. Alarm companies play an important role in ensuring that your family and property are protected. A good deterrent is installing alarm systems that best suit your needs.

Bucks County 9-1-1 advises all alarm system subscribers to contact their respective alarm companies and have them record your specific *municipality*. This will prevent any unnecessary delays in emergency response.

In Bucks County there are 54 municipalities; 31 townships and 23 boroughs. There are multiple postal city and town references that are spread out within individual municipalities (i.e. Doylestown, Levittown, Perkasie, Langhorne, Quakertown.)

As a home or business owner and as an alarm system subscriber, you have the right to ensure that you have optimum response to the correct location. It is imperative that you know what municipality your home or business is located in. Often alarm companies use the postal addresses without knowing the proper municipality.

This specific information on your location, when confirmed with the alarm company, will offer enhanced protection for your home/business. It will also assist the emergency call center in dispatching emergency responders to the correct location.
