The regular business meeting of the Northampton Township Board of Supervisors was called to order at 7:04 p.m.

PLEDGE OF ALLEGIANCE/MOMENT OF SILENCE

Chairman Selisker led the Pledge of Allegiance and held a moment of silence in support of the military, emergency service personnel, and North East Township Fuller Volunteer Firefighter Shawn Giles who was killed in the line of duty.

SPECIAL PRESENTATION

Whitetail Disposal Progress Report – Paul Brady

Mr. Brady, President and COO of Whitetail Disposal provided a quarterly update on trash services since taking over on January 1, 2023. Mr. Brady stated call volume is down, with no significant issues to report. The Board thanked Mr. Brady for the update.

Northampton Day Update

On behalf of Mr. Steve Bryer, Chairman, Mr. Jim Brady, Vice-Chairman of the Northampton Day Committee outlined the events planned for Northampton Day on Sunday, October 1, 2023. Mr. Brady called forward additional members of the committee, Mr. Peter Palestina, Mary Anderson, John Bishop, and Erik Lehman, and the group presented a \$19,000 check to Northampton Township Township for Sun Shades for the Miracle League Playground.

Mr. Pete Palestina spoke on the Bocce game that goes back 30 years. Mr. Palestina also spoke on the Talent Show and anyone wishing to participate should go to the website at <u>www.northamptonfun.com</u>.

CONSENT ITEMS

The Board meeting minutes of July 26, 2023, were presented by Mrs. Gasper.

ACCOUNTS PAYABLE

The accounts payable of August 9, 2023, for \$571,333.23, and August 23, 2023, for \$3,225,755.35 were presented by Dr. Rose.

A motion was made and seconded (Salzer-Gasper) to approve the consent items. All consent items were approved by Unanimous Consent.

NEW BUSINESS

<u>Consider Preliminary/Final Plan of Subdivision and Land Development Plan, Bucks County</u> <u>Roses, SLD 22-1 Buck Road</u>

Mr. Moore asked the applicants to introduce themselves.

Mr. Daniel McKenna, D.L. Howell & Associates Inc., Engineer for the project, and Mr. Thomas Kessler, Developer from KB Buck Road, LLC., (Buck Road Enterprises) introduced themselves for the record.

Mr. Moore stated that located along the northwestern side of Buck Road, approximately 550 feet southwest of the intersection of Buck Road and Spring Avenue, the proposal is to subdivide a 17.39-acre parcel into 15 lots along a new cul-de-sac, which will include 12 single-family detached dwellings and 3 open space lots. Proposed dwelling lots range from 0.92 to approximately 1.67 acres. The existing greenhouse and associated structures will be removed. An 80-foot-high wireless transmission tower and an associated structure are to remain on one of the proposed open-space lots. Public water and sewer will service the development. The R-1 Single-Family District permits single-family residential uses on parcels having a minimum lot area of 40,000 square feet and a minimum lot width of 150 feet.

Mr. Moore stated since the last meeting, the applicant has addressed the concerns of the Board and eliminated one dwelling. As a result, that lot will now become open space and contain the stormwater management system for the development, which will be maintained by the Homeowners' Association. In addition, the cartway has been reduced in width and shortened thereby reducing tree disturbance and preserving more of the woodlands on the site.

The following was provided for review. Based on the recent submission by DL Howell Engineering, however, the plans will be reviewed again given the modifications to the plan:

- 1. Waiver Request Letter DL Howell August 11, 2023;
- 2. Gilmore Associates Review letter June 19, 2023;
- 3. Pennoni Associates Review letter June 15, 2023;
- 4. McMahon Associates Review Letter May 9, 2023;
- 5. Township Planning Commission Memo April 12, 2023;
- 6. Bucks County Planning Commission Review letter February 23, 2022; and,
- 7. Copy of the Plan

A motion was made and seconded (Moore-Rose) for Preliminary/Final approval of the Bucks County Roses Subdivision and Land Development, SLD 22-1, subject to compliance with the Township Engineer's review letter dated June 19, 2023, the Township Planner's review letter dated June 15, 2023, and the Township Traffic Engineer's review letter dated May 9, 2023 in addition to their subsequent reviews based on the recent plan submission by DL Howell dated August 11, 2023. It is also recommended that the requested waivers be granted. Approval is subject to the following conditions:

- 1. The applicant shall enter into a land development agreement and escrow agreement in a form acceptable to the Township solicitor and engineer. This shall include a stormwater management maintenance and operations agreement.
- 2. A fee-in-lieu of tree replacement shall be required per the terms of the development agreement under the applicant's proposed tree replacement plan.
- 3. A fee-in-lieu of recreation/open space shall be submitted for \$6,782.41 for each new lot per the terms of the development agreement.

- 4. The applicant is responsible for obtaining any outside approvals that may be necessary, including, but not limited to the DEP, Conservation District, PennDOT, and the Municipal Authority. Further, approval is granted for the submission of any documents that may be required as part of the sewage facilities planning process.
- 5. All conditions and recommendations incorporated with the motion and minutes are subject to the Township Solicitor's approval letter..

Chairman Selisker called for Board comment.

The Board agreed this is a good resolution to the previous plan submitted and thanked the Bucks County Roses representatives for listening to the concerns of the Board and cooperating to make this plan feasible. Mrs. Fuller there will still be a further review of the plan and is looking forward to working with Mr. McKenna on the design.

Chairman Selisker called for public comment. None was heard.

Motion Passed 5-0.

Consider Bids for Salt Contract

Mr. Salzer stated on behalf of the Bucks County Consortium, Doylestown Borough advertised bids for rock salt in The Intelligencer on August 4, 2023, and August 11, 2023.

A proof of publication and bid tabulation sheet prepared by Doylestown Borough was provided to the Board.

Mr. Hucklebridge the Public Works Director recommended a contract be awarded to Silvi Concrete Products (DBA Riverside Construction Materials), Fairless Hills, PA at their bid price of \$66.00 per ton delivered, \$65.85 per ton undelivered. Our last contract was for \$67.76 per ton with Morton Salt Inc. and we used approximately 1,000 tons this past winter season.

A motion was made and seconded (Salzer-Moore) to award a contract for rock salt to Silvi Concrete Products (DBA Riverside Construction Materials)., Fairless Hills, PA at the bid price of \$66.00 per ton delivered to the Northampton Township Salt Shed, 150 Louise Drive, Ivyland PA 18974, and an undelivered price per ton of \$65.85.

Chairman Selisker called for Board and public comment. None was heard.

Motion Passed 5-0.

- The new proposed Dunkin Donuts on Second Street Pike is in construction and on scheduled to be completed by late fall. It is planned to have another retailer adjacent to the new Dunkin Donuts and no decision has been made on what will take the place of the old Dunkin Donuts in the Crossroads Plaza.
- The Old Mill Race Inn is in Land Development to construct 39 Residential Condominiums above commercial offices. This plan should come before the Board in either October or November.
