PUBLIC HEARINGS

Consider an Ordinance Amendment to Add All-Way Stop Intersection at Stonyford Road and East Village Road

Vice-Chairman Moore opened the hearing at 7:07 pm

Dr. Rose reviewed the ordinance amendment that was recommended by Bowman Engineering, the Township's traffic engineer, to add stop signs on both the northbound and southbound approaches of Stoneyford Road at its intersection with East Village Road.

As required, this ordinance was properly advertised in the Advance of Bucks County and posted on the Township website.

A motion was made and seconded (Gasper-Rose) to approve Ordinance #619 amending the Northampton Township Code, specifically Chapter 15, Motor Vehicles and Traffic, Part 2, to add stop intersections on both the northbound the southbound approaches of Stoneyford Road at its intersection with East Village Road.

Vice-Chairman Moore called for Board and public comment. None was heard.

Motion Passed 4-0.

Vice-Chairman Moore closed the hearing at 7:08 pm.

2024 Road Milling Bids

Dr. Rose outlined the bid results for the 2024 roadway milling project with a recommendation from Bowman Consulting Group, Ltd for bid award. The Township received five (5) bids using

the PennBid system, one of which was disqualified for not being an approved PennDOT contractor. The bid results are as follows:

Dr. Rose noted these roads represent approximately 6.6 miles of the Township system. Separately from this contract, the Township will be micro-surfacing approximately 3.5 miles of Township roads to meet the Board's goal of maintaining 10 miles of roads per year.

A motion was made and seconded (Rose-Gasper) to award a bid to James D. Morrissey, Inc., of Philadelphia, PA for roadway milling for \$2.43 per square yard for 1.5" maximum depth milling, in the amount of \$292,343.19 based on the quantities outlined in the bid documents and specifications for roadway milling bids.

Vice-Chairman Moore called for Board comment.

Dr. Rose reiterated the Board wants to meet the goal of 10 miles per year.

Mr. Salzer the Board is very diligent in this matter to maintain the 180 miles of road.

Mr. Moore explained the roads to be paved are done through a scientific method known as Robotics to determine the condition of the road to keep it impartial.
