Chairman Selisker led the Pledge of Allegiance and held a moment of silence in support of the military, and emergency service personnel.

#### Miracle League – 15-year Anniversary

Dr. Rose called forward Lenny Fisher, various other members of the Miracle League Board, and athletes. Dr. Rose presented a proclamation recognizing 15 years of contributions to the Northampton Community and for its service to over 250 individuals with special needs in Northampton Township and neighboring communities.

## Becky Arbaugh – Life-Saving Event

Chairman Selisker called forward Becky Arbaugh, Tri-Hampton Rescue and the Northampton Township Police Department to recognize her for her life-saving efforts in saving a child who was struggling to breathe. Mrs. Arbaugh stressed the importance of learning CPR.

# **CONSENT ITEMS**

#### **BOARD MINUTES**

The Board meeting minutes of April 17, 2024, were presented by Mrs. Gasper.

#### **ACCOUNTS PAYABLE**

The accounts payable for May 8, for \$1,413,741.36, and for May 22, 2024, for \$1,314,593.15 were presented by Dr. Rose.

A motion was proposed by (Salzer-Rose) for the approval of the consent items. All of which received unanimous approval.

## **NEW BUSINESS**

#### **Consider Recycling Disposal Contract Extension Renewal**

Mr. Moore explained the current contract with Waste Management for disposal of recycling materials expires on December 31, 2024. The initial contract was for a 5-year term with the option to extend the contract for two additional 5-year terms. This is a joint contract between Northampton Township, Upper Southampton Township, Lower Southampton Township, and Waste Management, executed when Northampton was part of the Southwest Bucks County Solid Waste Advisory Committee (SWBSWAC).

The contract provides for the municipalities to receive 70% of the value of any recycling materials sold by Waste Management as a credit toward the cost of material processing and disposal. The credit fluctuates each month based on the recycling materials market and affects the amount each municipality pays for disposal under the contract.

For example, in 2022, the monthly price for the sale of mixed recycling materials ranged from a high of \$70.14 to a low of (\$6.77) per ton, with an average monthly value of \$29.23 per ton. In 2023, the market improved and the range was between \$71.27 and \$48.09 per ton, with an average price of \$58.59 per ton. The higher value translates to a lower cost to the township. The 70% credit is applied monthly to the \$100.78 per ton cost to Waste Management for processing and disposal cost which is adjusted annually based on changes in the Consumer Price Index.

The provided Pricing Calculation Form for April 2024 shows the current value of recyclable materials, the current WM cost for processing and disposal (\$100.78), and the net cost per ton (\$44.31) to the Township after applying the 70% credit.

Northampton Township residents recycled 4,059 tons of material in 2022, and 3,818 tons in 2023. The three municipalities collectively recycled 7,184 tons of material in 2022, and 7,136 tons in 2023.

The Administration recommends the Board consider approving the attached Agreement that will extend the contract with Waste Management for another 5-year term.

A motion was made and seconded (Moore-Rose) to approve a 5-year contract extension with Waste Management of Pennsylvania for recycling materials disposal beginning January 1, 2025, and ending on December 31, 2029, and to authorize the appropriate Township officials to execute the contract extension Agreement.

Chairman Selisker called for Board and public comment. None was heard.

## Motion Passed 5-0.

# <u>Consider a Resolution Authorizing the Township Manager to Execute a Contract with PennDOT</u> for the Iron Works Creek Sidewalk Project

Mr. Salzer summarized the resolution that Bowman Engineering (formerly McMahon Associates) prepared a Richboro Sidewalk Improvement Plan that provides for sidewalk connections throughout Richboro.

In 2018, the Township received a PennDOT Transportation Alternatives Set-Aside (TASA) Grant to provide a sidewalk connection along both sides of Second Street Pike over the Iron Works Creek, that when complete, will provide a continuous sidewalk connection from Tanyard Road to

Crossroad Plaza. The current construction estimate is \$1.3million which will be 100% funded by PennDOT.

The funding match obligation for the grant requires the Township to pay for the design, preengineering, and construction inspection services. Since the beginning of the project, the Township has invested \$223,745. The remaining Township costs for construction inspection services are estimated at \$160,000 to be incurred in 2025. PennDOT anticipates advertising for bids in September, opening bids in October with construction beginning as early as December, weather permitting.

A condition of this reimbursement grant requires the Board of Supervisors to adopt the enclosed resolution authorizing and designating Township officials to execute documents for the TASA Grant Agreement.

A motion was made and seconded (Salzer-Rose) to adopt Resolution 24-7 authorizing and designating the Township Manager and/or Assistant Township Manager as the official(s) to execute documents for the Transportation Alternatives Set-Aside Program Reimbursement Grant Agreement.

Chairman Selisker called for Board and public comment. None was heard.

#### Motion Passed 5-0.

#### **Consider Authorizing the Sale of Surplus Equipment**

Mrs. Gasper explained that Dale Berton, Northampton Valley Country Club Golf Course Superintendent has indicated that we can sell the provided listing of surplus items. These items are expected to be valued at more than \$2,000 and as a result, can only be sold when authorized by the Board of Supervisors.

The Administration requests your approval to sell this equipment at a public auction on the Municibid website.

A motion was made and seconded (Gasper-Salzer) to authorize the Township Administration to sell surplus equipment at public auction as recommended by the Golf Course Superintendent in a memorandum dated May 15, 2024.

Chairman Selisker called for Board and public comment. None was heard.

#### Motion Passed 5-0.
