#### **PUBLIC HEARINGS**

# <u>Consider an Ordinance to Amend the Township Code Related to Motor Vehicles and Traffic to Prohibit Parking on a Portion of Treeline Drive</u>

Chairman Selisker opened the hearing at 7:07 pm.

Mr. Salzer stated the provided ordinance amendment was recommended by the Township Police Department to establish no parking from the Saint Leonard's Road Intersection along the Northern Side of Treeline Drive to the Western Intersection of Seedling Drive.

As required, this ordinance was properly advertised in the Advance of Bucks County and posted on the Township website.

A motion was made and seconded by (Salzer-Rose) to approve Ordinance #621 amending the Northampton Township Code, specifically Chapter 15, Motor Vehicles and Traffic, Part 4, General Parking Regulations, Section 402, Parking Prohibited at all times in certain locations, to establish no parking on a portion of Treeline Drive.

Chairman Selisker called for public and Board comment. None was heard.

#### Motion Passed 4-0.

Chairman Selisker closed the hearing at 7:08 pm.

#### **NEW BUSINESS**

#### **2025 Preliminary Budget Presentation**

Chairman Selisker called forward Mr. Pellegrino the Township Manager and Ms. Narisi, the Finance Director to present the Preliminary Budget.

Mr. Pellegrino presented a thorough review of the proposed 2025 budget and explained the variables that affect revenues and expenditures. He noted changes from 2024 to 2025 and stated there is a recommended tax increase of 4.5 Mils in the proposed 2025 budget.

The total Township real estate tax levy will be 32.5 Mils if the budget is approved as presented.

The tax millage is allocated to the Operating Funds as follows:

Administration, Police, Zoning & Public Works Services	10.00	Mils
Fire and Emergency Medical Services	8.50	Mils
Library Services	2.40	Mils
Parks and Recreation Services	2.93	Mils
Road Maintenance Services	1.00	Mils
Road Equipment Fund	0.57	Mils

Mr. Pellegrino briefly described the budget process, noting the Board is required by the Second Class Township Code to adopt a Preliminary Budget and advertise its availability for public inspection for 20 days. The budget may be adopted any time after the 20 days but must be adopted by December 31 each year.

The Board may make whatever changes it deems appropriate to the Preliminary Budget before its adoption. The Board may also make changes to the adopted Preliminary Budget before the final adoption scheduled for December 11, 2024, meeting within the limits established by the Second-Class Township Code. The Code states that a line item (Department total) may not be changed by more than 25% and the total budget may not be changed by more than 10%.

A motion was made and seconded (Rose-Gasper) to adopt the 2025 Preliminary Budget and advertise its availability for public inspection for not less than twenty days as required by the Second-Class Township Code.

Chairman Selisker called for Board comment.

All Board members expressed their agreement that the proposed budget is well-prepared and extended their gratitude to the Administration and Finance Department for their diligent efforts in developing it.

A discussion followed, with comments focusing on Public Safety, Road Paving, Infrastructure, and various other projects outlined in the proposed budget.

Chairman Selisker called for public comment. None was heard.

#### Motion Passed 4-0.

## Strategic Plan update:

 The Library Board, and Strategic Plan Committee would like to thank the Board of Supervisors for their support as the Free Library of Northampton Township moves forward with our Branding initiative. On October 30, we held our first information-gathering meeting with the marketing firm, SWELL, library staff, library patrons, library Board members, and township administration.

#### Adult Programming update:

- In partnership with the local non-profit, Welcoming the Stranger, the library has hosted 29 English as a Second Language classes for the fall session supporting more than 300 students working to learn the English language. The Fall session ends next week.
- On November 9, the library hosted our final 2024 Second Saturday program. These program costs are sponsored by Friends of the Free Library of Northampton Township each year. This year we held 10 programs and hosted more than 850 attendees, our highest attendance ever.
- Scam calls are being reported from individuals claiming to be from the Northampton Township Police. If you receive one of these calls, hang up immediately and do not engage.

#### Mr. Salzer made the following announcements:

- The Historical Commission would like to remind everyone that they serve as the
  custodians of the Township Archives, located at the Free Library. The archives
  house over 100 collections, including deeds, maps, genealogy records, and
  artifacts. The Township Archivist provides genealogy and historic research
  assistance, offers free digitization of family photographs and documents, and
  conducts oral history interviews.
- The Historical Commission has been actively working on several projects, including
  installing historical marker signs for the township-owned Addisville Reformed
  Church Cemetery on Second Street Pike and the Feaster Van Horn Cemetery on
  Middle Holland Road. They are also engaged in restoration efforts for township
  cemeteries. A cemetery survey was conducted, and plans for a possible phased
  restoration are underway.
- Since 2022, the Historic House Plaque Program has produced 53 plaques for resident homes, celebrating local history.
- The Commission extends its gratitude to longtime residents and members Jack Kay, Chairman Steve Arty, and Vice-Chairman Jim Finnegan for their dedicated service.
- Looking ahead to 2025, there will be three seat vacancies on the Commission. Interested residents are encouraged to apply to the Township as soon as possible.
- The Archives are open on Mondays from 4:00 PM to 7:00 PM, Wednesdays from 1:00 PM to 4:00 PM, and alternate Saturdays from 9:00 AM to 12:00 PM. Appointments are also available.
